Venue Hire Terms and Conditions

General Conditions

SCC is positioned adjacent to the Swan River and Town of Mosman Park recreational areas. Respectful consideration of the SCC Clubhouse facilities, the natural environment and our neighbours is a requirement of hire.

The hirer is solely responsible for the conduct of all persons and any event or happening at the facility for the duration of the hire period, and shall maintain good order and behaviour within the property and be solely responsible for compliance with these conditions and for meeting the costs of any damages or loss of equipment. Noise should be kept to a minimum with no excessive noise after 10pm. Smoking and pets are not permitted on the premises.

The SCC Clubhouse is not a serviced venue and as such, the set-up of rooms, catering requirements and cleaning must be undertaken by the hirer.

Ample parking is available at Jade Dobb Park adjacent to SCC.

All applications must be made in writing and the applicant must be over 21 years old. Submitting an application does not guarantee a booking and the SCC Committee has full right to approve or deny an application. Parties to celebrate 18th and 21st birthdays are subject to Committee approval.

Capacity

The building has a maximum capacity of 120 people (up to 90 people on balcony).

Times, Access and Cleaning

Rental times are noted on the schedule of Venue Hire rates with all set-up and clean-up to be completed within these times. If additional cleaning is required, this will be deducted from the bond.

Payment

All payments including applicable bond must be received at least 1 week prior to the booking. Where applications are required to the Town of Mosman Park (refer Venue Hire Application), all such applications must be completed, and payments received at least 2 weeks prior to the booking. Bond will be returned within 14 days following the hire subject to the venue, fixtures, fittings and equipment being in good condition.

Cancellation

Cancellations fees apply if less than 14 days' notice (25%) or less than 7 days' notice (50%).
